#### Terms and Conditions for Exhibitors/ Stallholders

Sunday 5 May 2024: Stangate House, cnr of Edgeware and Euston Road, Aldgate

The Adelaide Hills Garden Affair Inc. welcomes your participation in the 2024 gardening event.

To ensure that your organisation is clear on the arrangements for participation, these terms and conditions outline the responsibilities of the Adelaide Hills Garden Affair (AHGA), the National Trust of South Australia (NTSA) and Adelaide Hills Garden Affair Exhibitors (Exhibitor).

- 1. The Exhibitor acknowledges and agrees to be bound by these terms and conditions.
- 2. The Exhibitor shall have license to occupy a 3m x3m site (max 2 each) as nominated during the period of the event 4 to 5 May 2024. They do so at their own risk, must arrange for their own marque, tables and chairs if required and are responsible for the condition of that site(s) and for the safety of visitors and their employees while visiting the site in compliance with the Terms and Conditions.
- 3. INSURANCE: All Exhibitors must have a minimum of \$20 million Public Liability Insurance covering the period from 4 May 2024 and provide a copy of their insurance Certificate of Currency to AHGA, before 1 April 2024. Exhibitors indemnify NTSA and the AHGA for all claims and demands for loss or damage to property or for injury to any person. Food vendors are required to produce an appropriate temporary food license.
- 4. AHGA shall have the right to nominate the location of the site(s) applied for by the Exhibitor. Assigning or subletting the site requires the written permission of the AHGA. For any sound and prudent reason, the AHGA, may at its entire discretion cancel or postpone the event and this license shall cease to operate upon notice to that effect being served to the Exhibitor. In the event of CANCELLATION, site fees will be fully refunded but the AHGA or NTSA shall not be liable to the Exhibitor for any compensation on the grounds of loss of profits. The Exhibitor agrees that 50 percent refunds are given for a cancellation by the Exhibitor made in writing at least 21 days prior to the scheduled day of the event and that no refund is made on cancellations by the Exhibitor within 20 days of the event.
- 5. SETUP at Stangate House: Stallholders are encouraged to start setting up on Saturday 4<sup>th</sup> May between 12 noon and 5 pm and Security will be provided overnight. Stallholder access will again be open from 7am on Sunday 5<sup>th</sup>. The Exhibitor will inform AHGA when they intend to set up. Passenger vehicles and small light vans only are permitted and only on the 'Oak Tree' (bottom) lawn at any time and may be barred completely if the event is preceded by heavy rain.
  TRADING: All sites must be staffed and open to the public during the operating hours from 10:00am to 3:00pm
  - on Sunday 5 May 2024. At the conclusion of the event, the Exhibitor may commence dismantling at 3:00pm but vehicles' movement is prohibited until 4:00pm. Exhibitors must clear their site(s) by no later than 6.00pm on that day and the site(s) must be reinstated to same condition as at the commencement of the license to the satisfaction of AHGA and NTSA. Any costs of repair or restoration of the site(s) shall be borne by the Exhibitor.
- 6. AHGA and the NTSA shall not be responsible for any loss of or damage to the Exhibitor's property during the event including during the set up and dismantling periods.
- 7. SAFETY: This event will comply with all federal, state and local government requirements. This includes but is not limited to Work Health and Safety requirements to ensure the safety of Employees, Exhibitors, Contractors and the Public. Structures must be well secured and weighted down. **No tent pegs are permitted** due to the presence of buried essential services. To minimise disruption and ensure the safety of persons on the site, no machinery, vehicles, or other articles being displayed shall be moved to or from the Exhibitor's site(s) after 9:30am and before 4:30pm on Sunday 5<sup>th</sup> May. Emergency vehicles will be exempt to this provision. Exhibitor's animals or pets, other than those with prior approval, are not allowed on the site during the event, during setup or dismantling periods.
- 8. POWER: There are no sites with access to 240v power. The use of quiet generators by Exhibitors may be permitted with prior approval from AHGA. Electrical leads and equipment must have a current "test and tag" certification and have residual current device (RCD) earth leakage circuit breaker (ELCB) protection installed in the circuitry. No amplifiers or loudspeakers can be used by Exhibitors. Amplified announcements will only be made by the AHGA MC.
- 9. Officials appointed by the AHGA shall have the right to enter upon the site(s) of any Exhibitor at any time and remove any article, sign, picture, or printed material which in the opinion of the official is either not eligible for display or may be the cause of offence.
